

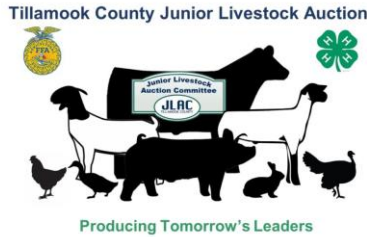
## **MEMORANDUM OF UNDERSTANDING with 4-H & FFA exhibitors who participate in the 2024 Tillamook County Junior Livestock Auction**

All participants must follow the 2024 Rules for Tillamook County 4-H & FFA Junior Livestock Auction Program.

Consignment of livestock will be to the Tillamook County Junior Livestock Auction Association. A commission of 7% of the sale price for all animals, except beef, and 4% for beef will be charged to offset the cost of conducting the sale. Brand inspection, check-off fees, etc. will also be deducted.

All Tillamook JLAC participants shall be:

1. A member in good standing in a Tillamook County FFA Chapter or in the Tillamook County 4-H Program. A member can participate in JLAC following the summer after high school graduation. JLAC participants must be residents of Tillamook County.
2. Responsible for certifying that all drug withdrawal requirements have been followed and that they have provided their project animal with humane treatment throughout the duration of the project.
3. Responsible for weighing in market animals at required weigh-ins.
4. Aware that animals not reaching the target weights or average daily gain requirements will not sell in the auction. These animals may be placed in appropriate feeder classes so member may still show the animal at fair.
5. Aware that animals must pass vet-check of the fair and prove to be controllable by the member as determined by the JLAC committee and FFA Advisor/4-H Agent. Animals who do not pass these checks will be sent home and unable to sell.
6. Aware that low quality, white ribbon animals as determined by the judge will not be offered for sale at the Junior Livestock Auction.
7. Required to participate in showmanship and market conformation classes.
8. Responsible for helping contact potential buyers prior to the sale.
9. Prohibited from selling their animal in the Junior Livestock Auction if they have lost that privilege due to disciplinary actions during fair.
10. Understanding that JLAC may use photos of members and their projects for advertising purposes.



11. Required to take their own animal through the auction.
12. Expected to assist with the auction as the Junior Livestock Auction Committee requests.
13. Required to be responsible for their animal until the close of fair on Saturday and provide it with feed and water between 6:00 – 8:00 p.m. on Saturday evening.
14. Responsible for absorbing the loss if animal is condemned during the slaughter process due to disease, use of medicine, infection, etc.
15. Aware that the Junior Livestock Auction Committee is not responsible for any losses during transportation occurring to animals not officially sold in the Auction.
16. Aware that member is responsible for the follow-up thank you note to buyer by 5:00 pm Saturday of fair.
17. Aware that members will be paid after the money from the sale is collected. Some buyers do not pay for their animals immediately and the JLAC needs to collect the money to pay the 4-H/FFA members.

I have read and agree to follow the Memorandum of Understanding and the Rules for the 2024 4-H/FFA Tillamook Junior Livestock Auction.
